
Sub. : Extension of IPD facility for Ayurvedic treatment.


With reference to IOM dated 25.02.2016 and Circular dated 24.2.2016, Competent Authority is pleased to accord approval for extension of IPD facility for chronic diseases and other ailments, subject to fulfillment of the following conditions :

1. Massage / Physiotherapy treatment should be undertaken on the advice of authorized medical practitioner.
2. Treatment should be carried out by a trained masseur.
3. The progress of such treatment should be reported at stated intervals to authorized medical practitioner.
4. It should be certified by authorized medical attendant that the treatment has been completed or that the case has reached the stage of maximum benefit from treatment.
5. The treatment should not be prolonged. In case, the period of such treatment is more than thirty four days, employee is required to take prior approval of Competent Authority, with the recommendations of authorized medical practitioner.
6. Medicines provided by the hospital at the time of discharge shall not be reimbursable.
7. Ayurvedic OPD treatment for a disease will be governed by the above mentioned IPD conditions.

**Sub: Extension of IPD Facility for Ayurvedic Treatment.**

It has now been decided to allow IPD facility for Ayurvedic treatment of chronic diseases and other ailments. One model Ayurvedic Centre can be empanelled for IPD by each Regional Office (two model Ayurvedic Centres have been empanelled for Head Office/HSMI/NCR).

Empanelment of one Model Ayurvedic Centre may be considered, keeping in view the empanelment guidelines as per HUDCO Medical Attendance Scheme. The number of beds required for empanelling in any Centre/Hospital for Ayurvedic treatment must be atleast 15 (fifteen beds), while the other requirement of having valid Registration / Income Tax Exemption Certificate, etc. may be also verified.

Before availing IPD treatment in the above hospitals, employee shall submit reports of investigation / diagnostic tests, etc. diagnosing the chronic diseases to the concerned office as notified in HO Circular dated 24.02.2016 (copy enclosed).

The above arrangement for extending IPD facility will be valid for a period of one year from the date of empanelment.



**SUB:- EXTENSION OF IPD FACILITY FOR AYURVEDIC TREATMENT.**
